### LL.B.3-year (Semester System) Course:

#### Eligibility and Admission Procedure:

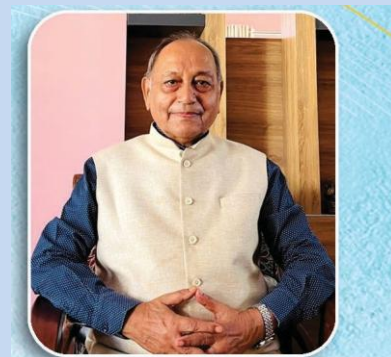
Intake Capacity: 120 (One hundred Twenty) students

Eligibility and Admission Procedure:

Admission to the first year of the 3 years, LL.B. Degree Programme in Law is strictly on merit.

To be eligible for admission, a candidate must have Bachelor degree in any discipline of recognized university securing not less than 45% marks in aggregate in case of General category applicants and 40% marks in case of SC, ST and 42% in case of OBC applicants.

Medium of Instruction: English



### BA.LL.B. (Hons.): 5-Years Integrated Course: Eligibility and Admission Procedure:

Intake Capacity: 60 (Sixty) students

- An Admission Test conducted by the Dibrugarh University for admission.
- Candidates who have passed the Higher Secondary Examination (10+2) or its equivalent examination securing not less than 45% marks in aggregate are eligible to sit for Admission Test.
- There is a relaxation of 5% marks for SC/ST and 3% marks for OBC candidates.
- Medium of Instruction: English

### LL.M. Course (2years) (Kept in abeyance)

#### Eligibility and Admission Procedure:

Intake Capacity: 16(Sixteen) students

- A Candidate must have not less than 45% (5% relaxation for the candidates under SC/ST/CBC/differently abled) marks in aggregate in 3(three) years LL.B or 5 (Five) years B.A./B.SC./B.COM/BBA.LL.B. Programme recognised by UGC and Bar Council of India (BCI).
- CAT to be conducted by the DIBRUGARH UNIVERSITY for admission.

## CELEBRATING 60 YEARS OF GLORIOUS DIAMOND JUBILEE

### JORHAT LAW COLLEGE AT A GLANCE

Jorhat Law College, the first law institute in Upper Assam and second in the whole of North-East India, is situated at Jorhat- the City known as the cultural capital of Assam. The Jorhat Law College fraternity is always proud of the rich heritage of the college and history of dedicated and selfless services of its founders and architects, whose sacrifices in its inception is a magnificent story in itself. The idea for establishing a law college at Jorhat, was first conceived and mooted by Late Bhorot Ch. Adhyapok, the founder teacher of Vocational High School, Korukatali, Baligaon, Jorhat and Noted Educationist & Social worker, Sjt. Dilip Kumar Sarma, the Head Master of Bidyadhar Sarmah High School, Jorhat and noted Educationist, Sjt. Tarun Ch. Gogoi, then lawyer of Jorhat Bar and Sjt Abani Prasad Bhattacharja, then lecturer in history of Jagannath Barooah College, Late Bhorot Ch. Adhyapok and Sjt. Dilip Kr.Sarmah took the main initiative to start the college at Jorhat. The matter was discussed in a meeting held at Jorhat Bar Library on 31<sup>st</sup> May, 1958 under the Chairmanship of K. N. Baruah. The meeting was attended by some eminent lawyers and citizens of Jorhat. The meeting constituted an executive committee with Radha Nath Hazarika, Bidyakanta Baruah, Nalini Nath Phukan, Rameswar Bora, Purnananda Bordoloi, Gunjanan Baruah, Nabin Chandra Buragohain, Surendra Nath Bharali, Pasu Gopal Baruah, Rukuddin Ahmed, Taher Borbora, Mal Chandra Pegu, Badiuz Zaman, Purnananda Pathak and Heremba Prasad Baruah as its members and asked it to explore the possibility of starting a college of legal education at Jorhat. The committee after a prolonged discussion on the matter decided to start a college named 'Jorhat Law College' and resolved to complete the necessary formalities to fulfil this objective. To materialize the objective a Governing Body of Jorhat Law College was constituted with Murulidhar Barooah as its Chairman. It is worth mentioning that Murulidhar Barooah was also the President of the Governing Body of Jagannath Barooah College for a long period.

The first meeting of the Governing Body of Jorhat Law College was held on 29<sup>th</sup> September, 1964 appointed Nalini Nath Phukan, the noted lawyer of Jorhat Bar, as the Principal and Secretary of the College and also appointed Tarun Chandra Gogoi and Abani Prasad Bhattachajee as its Joint Secretaries. Thus the dream of prominent citizens of Jorhat was realized and classes of Jorhat Law College began on October 1, 1964 at Gitarthi High School. The founder teachers of the college were Late Nalini Nath Phukan, Late Rameswar Bora, Late Mohesh Chandra Baruah, Late Manik Chandra Khound and Shri Tarun Chandra Gogoi.

Late Nalini Nath Phukan, the founder Principal, was the real architect of Jorhat Law College. It is for the selfless devotion of this philanthropist and noted lawyer, the Governing Body, two Joint Secretaries and above all the founder teachers, the College has taken its present shape and today takes pride in having moulded many lawyers and jurists of high repute. The concerted effort of these eminent citizens and lawyers had resulted in the establishment of a permanent campus of Jorhat Law College on a prime land in the heart of the city measuring more than 5 bighas allotted by the Government. The college was shifted to its own campus in the year 1967. It is heartening to note that Tarun Ch. Gogoi, with his background as social worker at Jorhat, had remained as Hon'ble Chief Minister of Assam for long 15 years. The College also takes pride in imparting legal education under two Universities.

At the time of its inception the college was affiliated to Gauhati University and after the establishment of Dibrugarh University in 1965, the college automatically came under it.

On June 30, 1996 Principal N. N. Phukan breathed his last and Nabin Ch. Buragohain, the renowned lawyer and former Member of Parliament, assumed the office of the Principal. Under his guidance and leadership there was some improvement of both real and financial assets of the College. In the year 2006, Justice S. N. Phukan, retired Judge of Supreme Court of India and illustrious son of the founder Principal N. N. Phukan took charge as the President of the Governing Body of the college and a new Governing Body was constituted under his leadership. The newly constituted Governing Body has been taking necessary initiatives to make the college one of the best institutes of legal education in entire North- East India. The Governing Body appointed a new Principal and a number of teachers as per the norms set by the University and the Bar Council of India. In addition to taking initiatives to make the LL.B course more viable and effective, the Governing Body with the permission of Dibrugarh University and the Bar Council of India, started the five year integrated B.A.LL.B (Hons.) course from the academic year 2008. The College has also started a regular LL.M. course from the academic session 2014-15. At the initiative of Jorhat centre of Indira Gandhi National Open University (IGNOU), the College started a number of diploma courses from the academic year 2016-17.
